## General Meeting Monday, February 4, 2013, 9:30 AM The Inn at Rancho Santa Fe

The speaker for the First General Meeting of the New Year is Dr. Gordon Hanson, Professor of Economics at the University of California, San Diego. Dr. Hanson has an impressive resume, including Professor for International Relations and Pacific Studies and Director of the Center on Emerging and Pacific Economies. We are fortunate to have so knowledgeable a speaker provide so timely an overview of the current economic conditions. ## My LOI Didn't Win!

Many of us have had the experience of seeing our favorite LOI fade in the voting, perhaps it was the one you shepherded or perhaps it was one you simply came to really support. You lobbied for your favorite in the Grant Working Committee; you committed your hopes for their success. It didn't make it in the voting. What to do? Many of us have charitable institutions we support beyond those of the RSFWF, perhaps because a loved one needed their help, such as hospice or research, and that organization offered comfort and hope to your family in your time of need. Or perhaps your professional life overlapped with the aims of the organization, such as military counseling or legal aid to the poor.

Rally your resources, donate anyway to the organization of your choice or volunteer your time! They will be especially grateful in this year of economic downturn.

## Philanthropy in the Age of Austerity

The year 2013 will bring tremendous fiscal constraints on all of us and these are not going to be relieved any time soon. The size of the US federal debt \$16,306,703,000,000, the reduced net household wealth (down 35% from 2005 to 2010 according to the Census Bureau), high unemployment, all put downward pressure on the economy and therefore on charitable giving. Charitable organizations depending on voluntary donations are already feeling the pain. The media report that charitable donations are down and we all get solicitations from charities, which bemoan their shortfalls.

This situation is likely to get worse. With the retroactive California wealth tax enacted this year and with the serious possibility of laws reducing the amount of charitable deductions for tax purposes, and with government cutbacks in support, our favorite charities and institutions are facing a new reality, the age of austerity. Museums and libraries, orchestras and choral groups, scholarship programs, medical research institutions are going to be forced to cut back. We have already seen this with the loss of one of our fine San Diego orchestras, Orchestra Nova.

Advocacy is rapidly becoming an important tool for successful and meaningful giving for the future and for educating members of Congress about the important work of foundations. Advocacy has become a philanthropic mission. The Council on Foundations ([www.cof.org](http://www.cof.org)) has a legislative committee that represents charitable organizations to Congress. It has taken several positions in support of foundation work, such as advocating simplification of the excise tax on foundations to a flat rate, maintaining current law on charitable deductions, extending and expanding the IRA charitable rollover. For more information on the impact of government laws on foundations and on private individuals, go to the Council website and look for their legislative updates.
